**Certification Fee - Abattoirs (Per Head)** 

Formula = (Base Fee + Loading\*) x Carcass + GST

Base Fee for Ovine = \$0.115

Base Fee for Bovine = \$1.00

Loading\* for Ovine = An amount between \$0.01 and \$0.10 (Optional)

Loading\* for Bovine = An amount between \$0.10 and \$1.50 (Optional)

Per Carcass = Total number of animals slaughtered.
